R. Deschenes read the public hearing notice as it appeared in the Millbury Sutton Chronicle.

Sean Lordan stated that he had purchased the Building in late August of 2023. He has operated his business out of 64

Worcester Providence Turnpike for 6 years and was planning to relocate.

R. Deschenes questioned if they were adding new staff and it was said they would be moving the current team down the street. There were six therapists and he was planning on hiring two more the following year. The Administrative staff included one Front Desk person, one Operations Director, one Biller who worked from home and then himself and his wife. He had 3 other locations but he started out in Sutton and hoped it would be their stalwart location.

D. Petrelli questioned if this was a larger location and it was responded that where they were currently was approximately 2,200 square feet in space and though he didn't know the exact size of the building he noted it was of good size of which

he stated the Board had copies of the plans.

D. Petrelli questioned what was going in on the second floor and it was responded that they were building out their offices. He described the exam room layouts with elevator access to second floor and breakroom for employees.

C. Matera questioned capacity and it was responded that each therapist sees 2 patients an hour and if maxed out it was thought 25-30 people at a time which he thought would be less than what the gym has at 5:00pm in the evening.

C. Matera questioned if there was a private septic and it was responded yes.

D. Petrelli questioned what the turf area was and it was said to be high ceiling area formally a loading dock which he was turning into an athletic training area.

R. Deschenes questioned if they were only open Monday through Friday and it was responded yes.

D. Petrelli questioned the hours and it said 7am and typically until 8pm. It was added that currently on Fridays they have been closing at 1pm which the staff enjoyed.

D. Petrelli questioned changes to parking and it was responded no changes.

D. Petrelli noted that it seemed that everything was staying as is other than internally adding some walls and carpeting. P. O'Hara questioned the number of parking spaces that currently existed and S. Lordan thought it to be around 32.

D. Petrelli questioned the location of the elevator and it was said it was in the location of the new hallway.

The Board agreed a site visit would not be required.

C. Matera questioned if a handicap ramp was onsite and it was responded yes.
