Review and Approve Minutes:

May 30th, 2023, minutes were approved by a vote. Vote carried a yes, by all present voting

members (C. Leary, R. Forsythe, D. Rossio, and K. Downer)

Public forum: None. Public hearing: None.

Board Business: M.H.C. inventory form updates submitted by D. Rossio. Two updates regarding Central Turnpike stone/rock supply history of a demolished property and 33 Buttonwood Rd. were presented to present members. D. Rossio also made a statement of her updated reports which included the history of a razed house on Central Turnpike, K. Downer noted that there is a planning review on two properties, 90 Armsby Rd and 27 Worcester Providence Turnpike. First review was Worc, Tpk. and D. Rossio noted she was not sure of the exact area. K. Downer noted it was north of the Drake Petroleum station on the east side of the highway, D. Rossio thought it was near an identified Native American site. Planning board meeting on September 11th, 2023, was announced by K. Downer and that several properties were added to the overlay article. No comments made by present members.
